President's Message: August 2023

I hope everyone is enjoying the summer and taking the much-needed rest and vacations that you all deserve. Over the last few years, we have been confronted with the growing need for mental health support and services. In a poll conducted by the Kaiser Family Foundation in the Spring of 2020, nearly half (45 percent) of adults in the United States reported that their mental health has been negatively impacted due to worry and stress over the Covid 19 virus. Many constituents in our counties are dealing with changes in employment status, looking for jobs to work from home that further increase concerns regarding isolation and potential financial distress. Anxiety and depression are major concerns that we see not only among our adults but rising among our youth. Many adults make an erroneous assumption that our youth have nothing to worry or to be depressed about.

In this day and age of instant messaging and thumbs up if you like or approve of me, our youth are losing the ability to discern intent, hurt, embarrassment or shame. Hiding behind a text when the message I send is inflammatory or belittling appears to absolve the sender of the harm they may have inflicted. The burden our youth are carrying many times is unseen. Parents whose anger lashes out in words that belittle them are often unaware of the impact their words carry. Words that shame, degrade, and stigmatize. To hear from Demetrius Starling, the senior deputy director for MDHHS' Michigan Children's Services Administration that the department is working on increasing access to mental health services is a major plus.

This is also a message to our board members and staff to safeguard your mental health. Take time out for you. Stop texting and emailing, pick up the phone and talk or, better yet, visit. How many times have you gone into a restaurant to see families sitting together on their phones, snapping pictures of what they are eating

Budget update, legislative is working and should have final budget approved by July. Targets are lower than we wanted. UCL is being implemented in more counties across the state and the goal is for all counties to be included. Dashboard was introduced and is in use. In the process of redetermination, hiring staff and training in a specific time frame. June's numbers are light but hopefully cases will rise. 1 day training for employees and looking at simplified reporting.

E. MDHHS updates from Doug Williams, in place of Demetrius Starling

FIS Integration and Support Program, regions pair together to provide direct support. Posted 16 positions (internal), pilot program will begin in fall. Offering training to Counties, motivational interviewing to assist workers, supervisors, and managers. Goal is to build relationships and trust with clients. There are currently 9300 children in foster care. That is down from last year's total of 14,000. MCSSA members are asked to be mindful about engaging families to consider fostering. System is working, 47% of those are placed with a relative in October 2022, today it is 54%, likely due to the definition of "relative". Update of placement policy. Currently there is a 28% turnover rate for child welfare workers. The department is offering pay increases to the most senior workers in Child Welfare and Cash Assistance. Cash & welfare departments have begun working together. Doug reported the Men of Color initiative seeks to increase department recruitment of them. He states that JJ (Juvenile Justice) has decreased the numbers of youth in facilities. Focusing on education credits so all credits are good at all educational facilities. Vista Maria proposed a short-term residential therapeutic program. It is hoped this will include youth being discharged from hospitals in addition to those transitioning from Child Care Facilities. This is an option to get kids into therapy sessions to help transition into the real world, including engagement with families. It is a work in progress. Doug Williams also stated that during June, Pride month and Juneteenth events are planned.
