President's Message: February 2024

We have now entered the second month of the year, where resolutions have been made, some already broken, and others still under consideration. February brings forth new opportunities for awareness and contemplation, particularly as we observe Black History Month. It is a time for reflecting on history, challenges, opportunities, and advocacy.

In this space, I have frequently emphasized the responsibility we bear in representing the constituents we serve, rather than viewing our positions solely as board memberships to enhance our resumes. It is crucial that we understand the challenges and circumstances faced by those who rely on the services provided by MDHHS. Sherrie Ross, representing District VI and serving on the advocacy committee for MCSSA, raised a concern during our recent meeting with the Senior Deputy Directors for MDHHS. This concern, brought to our attention by constituents in our county, directly affects Michigan's seniors, who may face potential income loss from Medicaid subsidies with as little as a \$10.00 increase in their social security. Fueled by our advocacy efforts, this issue has prompted a closer examination of a state policy that could significantly impact the constituents we serve.

We should remember an appeal made by one of our county directors during an annual meeting, urging the Senior Deputy Directors to repurpose the state cars that are auctioned off and make them accessible to the youth aging out of our foster care system, who require reliable transportation. This appeal has been under consideration within the department and shows signs of progress. It is important to acknowledge that change takes time, but it remains stagnant without proactive activation.

One of the primary ways to become aware of challenges and opportunities within our communities is through open communication. Therefore, I strongly urge you to host and attend your District meetings, where you can share the concerns voiced by your constituents and staff. Encourage your District chairs to participate in the Advocacy

5. MDHHS Updates from Demetrius Starling -Demetrius Starling started by reporting that in terms of upcoming initiatives for 2024, the department wants to focus on lifting voices of youth, predominantly ones that are currently transitioning to adulthood. Specifically, the initiatives go along the lines of providing requisite resources for the target group like mental health services, bridge card services, and Medicaid support. The Department also aims to have youth experience groups assist with the building of the program initiatives that are comprised of former youth that were in these programs. Additionally, the Department aims to relaunch the I Care for Children campaign in 2024, which includes consulting with youth in order to achieve the goals of the campaign. Demetruis Starling would like to have some youth invited to attend the MCSSA Legislative Conference. The committee liked this idea and suggested inviting youth to the Annual Conference as well. The Department also is continuing to work with other state agencies, as they are planning on giving a presentation in front of the state Board of Education to talk about legislative recommendations in terms of foster care education and outcomes. Lastly, we want to continue to give concrete economic support to at-risk families. We plan on going to a conference in Chicago in February to present the initiatives that Michigan has underway, including programs that have been very positively affecting Michigan families. We are also looking to expand the amount of child resource workers in resource centers across the state, given that this has been a very successful program.

- District II Allan Bruder-Next meeting will be held in January, waiting on specifics of that meeting.
- District III Yvonne Hebert-Not present/no update
- District IV Bob VanderZwaag-Not present/no update
- District V Barb Hanneke-Not present/no update, haven't heard from her since November. Will continue to try and reach her.
- District VI Sherrie Ross-We are currently in the process of reviewing a report concerning the universal caseloads. We have not reviewed the report in full but hope to later this week and will share the findings with the board.

7. Unfinished Business- Danielle Sirianni updated the committee that nothing has happened in the last month

In Lansing concerning legislation, however, we hope that more will occur once the legislature is back in session. Hope to report more at the next meeting.

8. New Business -Sherrie Ross brought up the topic of Medicaid and issues that concern seniors. She referred to comments by County Director Belinda Arbogast. If Social Security increases the overall cost of living benefits, a spend-down could potentially occur, given that many of these recipients would be in a new income bracket. This could require Seniors to spend as much as \$700 a month to qualify for many services. This could result in some of them losing Medicaid services due to inability to meet this requirement. Additionally, in terms of in-home care providers, a new EVV would require these employees to set up hours of service, and subsequently report. Hours to be compensated, as well as be subject to location tracking via cell phones to ensure that they are working during these hours.

Danielle Sirianni also gave a reminder of the February Listen & Learn. The Traverse Narcotic Team are the presenters, it will begin @ 1:30 pm.

- 1) Call to order Grenae Dudley, Chairperson @ 9:34 am
- Approval of Minutes December 13, 2023 motion to accept was made by Naomi Deo, seconded by Sandy Cook, motion carried.
- **3)** Corrections/Additions/Approval of the Agenda motion to approve was made by Naomi Deo, seconded by Sandy Cook, motion carried.
- 4) Announcements/Correspondence Frederick Group updates-On January 9th, updates were sent out to all board members by Danielle Sirianni. We have worked on the Up to the Minute newsletter, planning both of our 2024 conferences, as well as collecting this year's dues (38 counties have paid so far).

Mike Frederick added that when we took over the management of the association, we were given an old filing cabinet full of old MCSSA documents. Over the last few months, Nancy Peacock has completed the digitization of those documents, which eliminates the need to have the filing cabinet. What would the board like us to do with it? Grenae Dudley would like to donate the old filing cabinet.

- 5) President's Report Grenae Dudley-White reported that last month, Danielle Sirianni and Grenae Dudley met with Grand Traverse and Leelanau counties to present prevalent facts and statistics to them about their counties. They have indicated that they are both very interested in becoming members. Additionally, a subcommittee met last month to discuss a new district map, and I suggest that we approve the recommendation made by the subcommittee and approve the new map. Motion to approve made by Allan Bruder, seconded by Naomi Deo, motion carried.
- 6) Treasurer's Report Sandy Cook reported that as of right now, everything checks out and looks good.

Mike Frederick stated that the MCSSA CD worth \$90,000 took effect November 30th, 2023. Interest for both November and December is on treasurer's report, moving forward, we will go off the monthly bank statement instead of website indication for MCSSA monthly financials and will provide those numbers monthly to the board. Motion to accept treasurer's report by Allan Bruder, seconded by Christy Hilgers, motion carried.

- 7) MCMCFC Report/NACo Liaison Renee Beniak reported that they are currently working on two grants, one that concerns advancing education on dementia care, as well as one that concerns workforce development, such as recruitment retention and training, in nursing homes. Currently, we are aware of many nurses going back to school to receive advanced degrees and higher certifications, which is a positive trend. Additionally, we have a social media campaign kicking off this month for care facilities. Next month, we will be attending the NACo conference in Washington, D.C. While there, we also hope to incorporate in many visits to Capitol Hill, as well as meet with both Michigan Senators, Debbie Stabenow, and Gary Peters. With them, we plan to cover topics such as Medicare and Medicaid benefits, as well as county nursing homes and the challenges that they are facing, such as staffing shortages. Additionally, CMS has put out new staffing regulations that could potentially make it very hard for facilities to keep up with these regulations, so this is also an area of concern for us.
- 8) Advisory Committee Report Naomi Deo stated that this morning, Demetrius Starling gave us many good updates concerning the Department. He indicated that they are in the process of asking for input from impacted youth to create better programs concerning the transition to adulthood. Additionally, he indicated that the Department is working on collaborating with private entities to provide economic resources to underprivileged youth. He also mentioned being open to giving a presentation on the Used Cars for Youth program headed by the Department at one of our upcoming MCSSA conferences. He also provided some clarity on the social security spend down issue and hopes to have more information at our February board meeting in order to lobby legislators and potentially work on new legislation.
- 9) Legislative Updates Sharon Campbell was unavailable, updates given by Danielle Sirianni. There has been no legislative activity in the last month, however, hopefully there will be some pieces moving through both chambers in the next month, given that they return to session today. We hope to have a report at the February meeting.
- 10) Development and Education Committee Bob VanderZwaag was unavailable, so Danielle Sirianni reported.
 - Legislative Conference The DoubleTree by Hilton, Lansing, MI April 9 & 10
 As of right now, our goal is to have registration packets out by the end of the month. We want to encourage early registration, and this will be incentivized by being entered into a

drawing for a gift card if you register by a specified date. Additionally, the agenda is set, but is tentative, and we are currently working on filling spots for speakers.

- 2024 Annual Conference Great Wolf Lodge, Traverse City, MI September 16-18 Currently, we are working on the mental health topic for the conference. Bob VanderZwaag has been in contact with Dr. Kathy Bailey, a professor at Grand Valley State University, who will be the headlining speaker for the conference. We are also looking to fill slots for other speakers, and the Traverse City Tourism Bureau will be coming to the conference as well to inform attendees of things to do in the Traverse City area. Additionally, we are currently looking at locations for the 2025 and 2026 annual conferences. Some cities that we have been suggested are Muskegon, Frankenmuth, Clare, Bay City, Big Rapids, and Boyne. Mark Wolfe informed the committee that Bay City will be working on their bridges and there will be detours, it's expected to take 3 years. Lastly, our next Listen and Learn session is scheduled for February 5th featuring the Traverse Narcotics Team.
